Introduction

Royal Decree 1067/2015, of November 27, created the State Research Agency (hereinafter Agency) and has approved its Statute. Its effective constitution took place on June 20, 2016, with the constitutive meeting of its Governing Council.

The Agency is created with the mission of contributing to the promotion of scientific and technical research in all areas of knowledge through the competitive and efficient allocation of public resources, the monitoring of financed actions and their impact, and advice on the planning of the actions or initiatives through which the R&D policies of the General State Administration are implemented. The effective constitution of the Agency took place on June 20, 2016.

Article 23 of the Agency's Statute provides that the Director prepares and submits to the Governing Board for approval the general activity report corresponding to each financial year. Pursuant to the Agencies Law, said report must be submitted before June 30 of the immediately following year.

In compliance with this forecast, the general activity report of the Agency corresponding to the year 2020 has been prepared and submitted for the approval of the Governing Board, at its meeting on June 30, 2021.

The general activity report has been prepared following the objectives, programs and activities contained in the Agency's Annual Action Plan for the year 2020.

Consequently, the 2020 general activity report reports on the activities carried out in the following areas (corresponding to the axes of the Annual Action Plan):

- Consolidation and structural development of the Agency.
- Management of financing instruments.
- Scientific-technical evaluation of the proposals.
- Monitoring of aids
- Management of agreements, management assignments and provision of services.
- Communication, dissemination and representation in R&D forums.

I. Consolidation and structural development of the Agency.

Program 1. Adaptation of the Agency to Law 40/2015 of October 1

During the year 2020, the Agency had to address the adaptation to Law 40/2015, of October 1, as required by the fourth additional provision of said Law.

Law 40/2015, of October 1, abolishes the State Agencies, which have a period of three years from its entry into force to modify their statutes and become one of the entities that, in accordance with said Law, constitute the institutional public sector.

However, the bill for the General State Budgets for the year 2021, which finally materialized in Law 11/2020, of December 30, on the General State Budgets for the year 2021, brings about an important change in the regime of the Agencies, which permanently recover their status from the extinct Law of Agencies, although now its regulation is contained in Law 40/2015, of October 1.

It will now be necessary to implement a statutory modification, although with a different content from that initially foreseen in the Annual Action Plan for 2020.

Program 2. Preparation of the multi-annual Action Plan.

In parallel to the action foreseen in program 1, in order to adapt to the provisions of article 85 and transitory provision 2^a.2 of Law 40/2015, of October 1, the Agency would undertake during the year 2020 the preparation of a multi-year action plan for the 2021-2023 period, which updates the strategic lines contained in its initial action plan. Said plan, which was to be prepared under the coordination of the Services Inspection of the assigned Department, will follow the methodological guide of the General Services Inspections of the Ministerial Departments for the control of effectiveness referred to in articles 85 and 86 of the Law 40/2015, of October 1, on the Legal Regime of the Public Sector.

Likewise, as far as possible, the plan will take into account as a starting point the structure, objectives and indicators set in the management contract proposal for the 2018-2021 period approved by the Governing Board on June 28, 2018. The plan should be approved by the Governing Council of the Agency and by the Assignment Department. The change in the legal regime of the agencies referred to in the previous section has also affected this objective, since, in accordance with the new regulation, multi-year planning must be carried out within the framework of the management contract, in the form and with the content regulated in the new article 108 ter of Law 40/2015, of October 1.

The preparation of the management contract has been included in the 2021 Annual Action Plan.

Program 3. Human Resources Management

1) Approval and implementation of a productivity system for meeting objectives

The Governing Council of the Agency approved on November 26, 2019 a proposal for a multi-year productivity program for meeting objectives, which covers the years 2019 to 2022.

The objective of this program is to encourage the productivity and performance of the Agency's personnel, which will favor the fulfillment of its objectives, rewarding effort and dedication.

It is also pursued to make the jobs at the Agency attractive, in such a way as to contribute to the coverage of currently existing vacancies and to retain qualified personnel currently assigned.

Productivity by objectives is based on the definition of objectives to be met and the indicators of compliance with these objectives and will be paid on a small part of the income generated annually by reimbursement of aid and provision of services

In 2020, was presented to the Ministry of affiliation, in order to have its approval processed by the Ministry of Finance. This ministry proposed various changes and improvements that were incorporated into the proposal. The PCO has not been approved during that year.

- 2) Preparation and execution of the Training Plan.** A Training Plan has been prepared and approved to improve the skills necessary for the proper functioning of the organization and the efficient provision of services. The elaboration of the Plan was carried out in coordination with the Ministry of Economy, Industry and Competitiveness and with the participation of the representatives of the workers. A total of 12 courses have been taught, with the following details:

1. Preparation and execution of the Social Action Plan 2020.

The social action aid plan for Agency workers for 2020 has been prepared and execute. which affects both measures of an individual nature (staff study aid, health protection, descendants and ascendants, transport, disability, situations of gender-based violence and situations of an exceptional nature) as well as measures of a collective nature (medical check-ups, dining room aids, etc.). Grants have been awarded for an amount of 23.828 euros.

2. Measures for the incorporation of new personnel in the Agency.

In 2020, a specific competition was published for the provision of jobs for civil servants in the Agency, which has allowed the definitive coverage of 21 jobs. In 2019, a specific one was also called, resolved in the last quarter of 2019, with which another 23 jobs were definitively covered. A study and proposal of positions to incorporate into the Public Employment Offer (OEP) for the year 2020 was presented. The positions that have been obtained:

- 5 positions of the OPIS Specialized Technicians Scale of free shift
- 3 positions of the of the Scale of Specialized Technicians of OPIS of internal promotion
- 4 positions of the Scale of Specialized Higher Technicians of OPIS on free shift.
- 4 positions of the Scale of Specialized Higher Technicians of OPIS for internal promotion

The positions of the 2021 EPO of the General Bodies of the General Administration of the State of free shift and internal promotion, are pending.

In 2020, the following have joined the State Research Agency, from positions called in the OEP in 2017 and 2018-2019:

- 2 positions of the OPIS Specialized Technicians Scale of free shift
- 1 position of the Scale of OPIS Specialized Higher Technicians on free shift (internal promotion)
- 1 position Fixed labor, with the category of Higher Degree in Technical and Professional Activities (Free shift).

In 2021, the incorporation of the staff of specific bodies of the OEP for 2018-2019 will take place (10 position of the General Administrative Staff of the State Administration, 5 positions of the Auxiliary General Corps of the State Administration, 1 position of the Management Corps of the Civil Administration of the State and 1 position of the Body of Management of Systems and Informatics of the Administration of the State).

Program 4. Adaptation of administrative, management and monitoring processes.

1. **Basic Procedures Manual.** This manual should include the catalog of basic procedures of the Agency, and within each one of them describe, among other aspects, the activities that it includes, the intervening units, the computer tools to be used, the applicable regulations and the associated deadlines.

The manual should include the development of procedures in the following management areas: to. Procedures associated with the management of aid for R&D&i.

b. Procedures for organizing economic and budgetary management.

c. Procedures for the management of Human Resources

In compliance with this objective, in 2020 the Agency approved its first manual of basic procedures, which will be updated in successive years to adapt to any regulatory or organizational changes that may occur.

2. **Acceleration and simplification committee.**

The Annual Action Plan for 2019 provided for the creation of an acceleration and simplification Committee in the Agency, in order to identify and analyze the aspects that limit the agility in the life cycle of the calls, and the rest of the procedures that accompany the execution of the grants, or that are likely to be simplified and allow improving external visibility and optimizing procedures for users and for the Agency's own work. The Annual Action Plan for 2020 contemplated continuing with the planned actions: publication of the survey and preparation of the report on problems and solutions.

During the first months of 2020, the survey has been improved, and the IT infrastructure has been tested with different groups. Its 90 questions have a very broad coverage of the Agency's activities. On the other hand, the computer support used makes an automatic report of the data that will be collected.

Program 5. Communication and visibility of the Agency's Activities

The Agency's Communication and Transparency Plan was approved at the meeting of the Governing Council on December 4, 2017. This document includes the communication and dissemination instruments that will make it possible to give visibility to the Agency's activities and actions and towards its employees. Likewise, it includes the lines of action that mark transparency in administrative activities and compliance with good governance obligations by the public officials of the Agency, as well as accountability and commitments to present accurate and complete information on the results and procedures used in management. The concrete measures execution measures of this plan for the year 2020 are in Axis 6.

Within this program 5 and as a necessary instrument to be able to execute the Communication and Transparency Plan, in 2020 the creation and start-up of the Agency's website and intranet was scheduled.

Although these activities have made significant progress in 2020, it has not been possible to complete their implementation, which has been carried out in 2021.

On the other hand, progress has been made to involve workers in the Agency's activities and matters of common interest, either through corporate emails and/or general meetings or by Units. We consider it important to maintain regular contacts, in which all workers are informed, and at the same time allow interaction with the concerns and proposals of all staff.

Program 6. Consolidation of common services

In order to consolidate the necessary services for the operation of the Agency, in 2020, the following activities should be undertaken, mainly:

1. Implementation of the computing and storage infrastructures, and the support services, security, backup and associated systems, which will be shared with the Assignment Ministry. Progress has been made on this objective during 2020, with the corresponding tender. The signing of the contract with the winning company and the implementation of the infrastructure has been carried out in 2021.
2. Preparation of a feasibility study to develop a new IT system for processing aid. This study, once completed, will allow, when the necessary funding is available, to tender and develop "ex novo" a harmonious and modern aid management system. This study has been commissioned from the company TRAGSATEC and has been delivered in July 2020.
3. Subscription of a joint protocol with the Ministry of Education and Vocational Training, to regulate the joint use of the common facilities of the Torrelaguna, 58 and 58bis street complex.

The special circumstances of the year 2020, in a context of a pandemic, have prevented progress in the development of this joint protocol.

II. Financing instruments: calls.

The Agency has among its functions the management of the programs, instruments and actions assigned to it within the framework of the State Plans for Scientific and Technical Research and Innovation, any other that is expressly assigned to it by the General State Administration or the derived from collaboration agreements concluded with other entities or from other actions.

Managed calls are the nerve center around which the Agency's activity pivots: the main instrument for financing research. The launch of a call is similar to a transmission mechanism, in which each gear acts in synchronization in order to start a machine. It begins with the publication of the call and ends with the scientific, technical and economic verification of the use of the funds granted. It is therefore a process with a long life cycle, which remains alive for several years and which starts every time a call is published.

It comprises several successive phases that follow a temporal order: the instruction, the evaluation of the proposals, the economic-budgetary management, and the monitoring and justification of the financed actions.

1. Instruction.

In this phase, the preparation, approval and publication of calls for aid are coordinated. During the year 2020, 16 calls were managed (9 calls published in 2019 and the rest in 2020), a process that begins with the drafting of the texts, the request of the pertinent reports and their publication in the Official State Gazette and in the National Grants Database. The management of these calls in 2020 involved the instruction of 18,177 files: review of applications, corrections, withdrawals and resolution notifications.

It also involves the maintaining the system of entities, which is the repository where aid applicants must register and provide the necessary documentation to prove their legal nature and the legal representatives that interact with the Agency throughout the life of the call. For this reason it is necessary that it be completely updated, and very regularly, modification requests, registrations and cancellations, etc. are made. Specifically, 1.703 during the past year.

2. Scientific and technical evaluation of proposals.

The scientific-technical evaluation of the proposals and their internationally proven development protocols are the fundamental pillars that guarantee the proper functioning of competitive competition, based on criteria of excellence and the correct allocation of budget funds. The aim is to ensure a rigorous and objective external evaluation system that allows the opinion of individual experts to be compared and prioritizes all applications for funding, taking into account the quality and relevance of each proposal, the scientific-technical solvency of the research team and the expected scientific and social impact of it. At this stage, the ex-ante evaluation processes of aid applications submitted to calls managed by the AEI and included in the State Plan for Scientific and Technical Research and Innovation are organized, coordinated and managed. In a generic way, this evaluation process has two different stages:

- The remote evaluation carried out by individual experts with in-depth knowledge of the subject matter of the proposals submitted, who carry out technical reports on the quality and relevance of each application submitted.
- The assessment and prioritization of requests, carried out by a panel of experts who value a significant number of them, and in view of all the technical reports available by the panel, assign by consensus a final assessment and prioritize the requests for the proposal of financing.

The evaluation process has been adapted to the needs and evaluation criteria established for each order of bases and call of the State Plan. In the calls in 2020, 160 commissions have been managed, which have generated 16.060 reports and 1.671 allegation reports.

To carry out this task, the Agency has the support of scientific and technological Collaborators, assigned in accordance with article 19 of the Science Law.

3. Economic and budgetary management: payments

Payment of aid granted is generally made by annuities. The first annuity is issued due to the resolution of the concession and the rest of the annuities, once the economic justification of the previous annuity and the scientific justification have been received within the terms established by the different calls, after positive evaluation of the reports presented. Payment requires prior verification of the requirements that the General Subsidies Law requires of beneficiaries, an activity that is not minor, since all responsible declarations and certificates provided by applicants must be reviewed, as well as with explicit prior authorization, that of the fulfillment of its obligations with the Tax Agency and with Social Security. The data for 2020 are:

4. Monitoring of grants

The Monitoring of the grants approved by the AEI includes both the management of incidents (changes related to the initial request, changes in the resolution of the concession) and the verification, monitoring and evaluation of the activities financed both during the period of execution of the same as at the end. This monitoring is carried out from a scientific-technical and also an economic point of view, as determined in the calls and as required by law.

4.1. Scientific – technical monitoring of grants.

Each call has a programmed follow-up, in fact, the execution reports and their periodicity that must be presented by the beneficiaries are determined in each call. Once evaluated by the external collaborators, if it is favorable, the corresponding certificate of conformity is issued, necessary for the release of the payment of the following annuity. In short, it is an intermediate evaluation of the aid granted.

In addition, face-to-face monitoring sessions have been held throughout the year for the presentation and intermediate monitoring of the status of execution of the projects financed.

In this part of the process, there is the possibility of requesting the modification of the aid conditions by the beneficiaries. In this case, the scientific collaborators issue the technical reports and based on them, the authorization or denial of the modifications is determined.

The scientific-technical monitoring is proposed from two points of view depending on the type of call:

The calls with scientific-technical fields that have a thematic orientation defined in the state plans, responding to the needs of the scientific community and the main social and economic challenges of the country, exercised by the Subdivision of Scientific-Technical Thematic Programs¹.

4.2. Economic monitoring of grants.

This procedural phase focuses on the economic and financial control and monitoring of the financed actions, specifically:

- The administrative review of the supporting account and economic audit of the expenses of all the files. Depending on the result, the refund procedure is initiated for the amounts that have not been justified or whose justification has not been adequate. This procedure includes the issuance of a request for information, the initiation agreement, the opening of the hearing process, the assessment of the allegations presented by the beneficiary and notification of the final resolution.
- Refunds. This procedure includes the issuance of the initiation of reimbursement agreement, opening of the hearing process, assessment of the allegations presented by the beneficiary and notification of the final resolution of reimbursement, and where appropriate, loss of the right to collect annuities pending payment. Likewise, it also includes the issuance of the payment document model 069 of the Tax Agency or in the future of the own refund system established by the Agency.
- Cancellation of guarantees and seizure of guarantees. The cancellation procedure of guarantees presented before the General Deposit Box includes the issuance of the cancellation order and the referral to it, as well as the notification to the beneficiary that said remittance has been carried out so that it can cancel the guarantee. For its part, the procedure for seizing guarantees includes notifying the beneficiary of the start of the procedure as well as the opening of the hearing process, the assessment of the allegations and, in the event that they are rejected, issuance of the request for seizure. and sending it to the Delegate Intervention for its inspection and to the General Deposit Box.
- Certification of European structural funds. The State Agency manages European Regional Development Funds (ERDF) and European Social Fund (ESF) - ESI Funds - with which some of the calls managed by the Agency are co-financed. This entails the need to carry out an economic and financial follow-up as well as the justification to the Management Authorities of the European Regional Development Fund and the European Social Fund of the eligible expenses of the projects co-financed in order for the European Commission to proceed with the payment of aid with said funds.

V. External collaborators

Article 19 of the Science Law establishes that public financing agents and their organs, agencies, and entities may temporarily, full-time or part-time, assign career civil servants who are researchers, technological development experts, or specialists related to the field. of the investigation, so that they collaborate in tasks of elaboration, management, monitoring and evaluation of scientific and technical research programs, with the prior authorization of the competent bodies and the entity in which the research personnel provide their services..

The Agency makes use of this fundamental authorization for the evaluation and management of the State Plan of R + D + I.

The assignments have two modalities:

- Temporary collaborators who carry out continuous and part-time tasks of technical support and advice in the processes of evaluation and scientific monitoring of the grants. They collaborate with the agency for an average period of 3 years.
- Evaluators, who are assigned in a timely and generally remote manner the technical scientific evaluation of proposals submitted to the calls for grants.

In 2020, the Agency had 16.380 evaluators and 314 different collaborators who have been assigned temporarily at some point during the year. The monthly average of temporary collaborators has been 260, the months of May and June were the ones that had the highest number of temporary secondments (265) each. There were also 26 temporary collaborators during the months of April, May, June and July, different from the previous ones, for the Carlos III Health call, "Strategic Action in Health".
